**Reporting of patients with  
severe human swine influenza A(H1N1) related illness**

Human Swine Influenza (HSI) has now taken root in our community. As of June 25, out of 506 laboratory confirmed cases reported in Hong Kong, 65% are locally acquired. Laboratory data from our Public Health Laboratory Centre (PHLC) has revealed that this influenza strain has become the commonest influenza strain circulating in Hong Kong.

HSI in Hong Kong is so far manifesting itself in a relatively mild manner resembling seasonal flu, like in most other countries. The number of confirmed cases represents probably a small fraction of infections that have occurred, as many infections may remain undetected due to the mild nature of the illness. Since local infections now constitute the majority of HSI cases, you are not required to report individual cases suspected to be suffering from HSI to CHP as per the reporting criteria previously provided.

As we enter fully the mitigation phase of the HSI epidemic, our priority is now put on detection of serious or fatal cases related to HSI. To fulfill this aim, the Public Health Laboratory Centre is providing HSI laboratory testing for your patients who satisfy the attached criteria. **Please take specimens from such patients and send to our Public Health Laboratory Centre. They will be tested free of charge.**

If these patients are **confirmed positive for Human Swine Influenza A/H1N1**, **please report to our Central Notification Office (CENO)** using the attached form by fax (2477-2770) or by phone (2477-2772) or by CENO online (<http://www.chp.gov.hk/ceno>). For reporting outside office hours, please contact Medical Control Officer (MCO) of DH at Pager: 7116 3300 call 9179.



Currently, the Hospital Authority (HA) is operating 8 Designated Flu Clinics (DFCS) for diagnosis and treatment of patients with symptoms of influenza-like-illness. Patients with severe illness would be admitted to hospitals for further management.
