Human Cases of Novel Coronavirus Infection

We would like to alert you that the World Health Organization (WHO) reported two human cases of novel coronavirus infection as of 23 September 2012. One had travelled to the Kingdom of Saudi Arabia (KSA) and Qatar while the other one was a Saudi national.

According to WHO, a 49 year-old male Qatari national, with travel history to the KSA prior to onset of illness, developed symptoms on 3 September 2012. On 7 September, he was admitted to an intensive care unit (ICU) in Doha, Qatar. On 11 September, he was transferred to the United Kingdom (UK) by air ambulance from Qatar. Laboratory testing confirmed the presence of a novel coronavirus. The patient is currently being managed in strict respiratory isolation in UK. The sequencing of the virus isolate from this patient was compared with the isolate from another fatal case in a 60 year-old male, Saudi national, reported earlier in September. This comparison indicated 99.5% identity, with one nucleotide mismatch over the regions compared. According to UK Health Protection Agency (HPA), both patients presented with acute, serious respiratory illness with symptoms of fever, cough, shortness of breath and breathing difficulties. The incubation period is currently considered to be up to seven days by the HPA.

Given that this is a novel coronavirus, WHO is currently in the process of obtaining further information to determine the public health implications of the two confirmed cases. To date, no additional confirmed case was reported worldwide. With respect to current findings, WHO does not impose any international travel or trade restrictions.

Coronaviruses are a large family of viruses that can be found in humans and animals. In humans, coronaviruses can cause mild illness like common cold as well as severe illness like severe acute respiratory syndrome (SARS). Coronaviruses are typically spread like other respiratory infections such as influenza. This infection is therefore likely to be passed from person to person when an infected person coughs or sneezes, though much is unknown at this stage.

In view of the emergence of a novel coronavirus and the severity of illness in the two confirmed cases, the Centre of Health Protection of the Department of Health will collaborate with the Hospital Authority and private hospitals to enhance surveillance for any suspected case of novel coronavirus infection. Please report patients who satisfy the following criteria to the Central Notification Office (CENO) of the Centre for Health Protection (Fax number: 2477–2770) by fax of the completed form (Appendix). Please also contact CENO at Tel: 24772772 during office hours or the Medical Control Officer (MCO) at Pager: 7116–3300 call 9179 outside office hours when reporting any suspected case.

Reporting Criteria

Any patient who developed pneumonia or died of unexplained respiratory illness; **AND**

had history of travel to Kingdom of Saudi Arabia or Qatar within 7 days prior to symptom onset

Please be reminded any suspected cases of novel coronavirus infection should be put under strict isolation (presumably a negative pressure room). All staff who will have contact with any suspected case are advised to wear full protective equipment.
