Important Points

Pneumococcal Vaccine

- All residents in Residential Care Homes for Elderly (RCHEs) and residents aged 65 or above residing in Residential Care Homes for Persons with Disabilities (RCHDs) should receive
1 dose 13-valent pneumococcal conjugate vaccine (PCV13)
 **(with 1 year apart)**
1 dose 23-valent pneumococcal polysaccharide vaccine (23vPPV)
- **No re-vaccination** is needed after the completion of PCV13 and 23vPPV vaccination

Pneumococcal Vaccine

- (a) Residents who have already received 23vPPV are eligible for one dose of free PCV13 one year* after previous 23vPPV vaccination

Example (a)		1 st dose	Recommended dose interval	2 nd dose
Previously vaccinated	(a)	<u>Previous dose(s) 23vPPV[^]</u>	≥ 1 year*	<u>2018/19 season PCV13</u>
	e.g.	1/11/2017	→	1/11/2018

[^] Regardless the number of doses of 23vPPV received previously

* 1 year is assumed to be one calendar year

Pneumococcal Vaccine

- (b) Residents who have never received PCV13 or 23vPPV before are eligible for one dose of free PCV13, and followed by one dose of free 23vPPV one year* later

Example (b)		1 st dose	Recommended dose interval	2 nd dose
Unvaccinated	(b)	<u>2017/18 season</u> PCV13	≥ 1 year*	<u>2018/19 season</u> 23vPPV
	e.g.	30/12/2017	→	30/12/2018

* 1 year is assumed to be one calendar year

Pneumococcal Vaccine

- (c) Residents who have already received PCV13 are eligible for one dose of free 23vPPV 1 year* after previous PCV13 vaccination

Example (c)		1 st dose	Recommended dose interval	2 nd dose
Previously vaccinated	(c)	<u>Previous season(s)</u> PCV13 [^]	≥ 1 year*	<u>2018/19 season</u> 23vPPV
	e.g.	30/12/2017	→	30/12/2018

[^] Regardless the number of doses of PCV13 received previously

* 1 year is assumed to be one calendar year

Pneumococcal Vaccine

This year (2018/19 season),

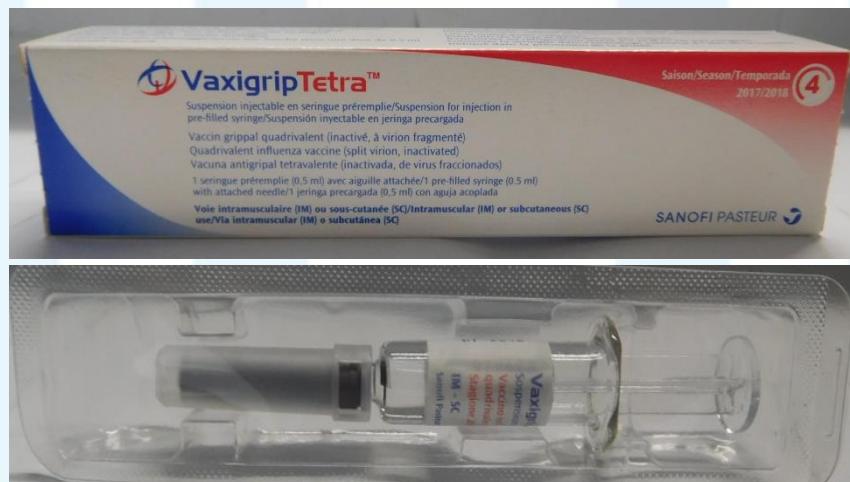
- For eligible residents who received PCV13 in 2017/18 season AND **have not yet received 23vPPV in the past**
 - 23vPPV should be given 1 year after previous dose of PCV13

Seasonal Influenza Vaccine

- VaxigripTetra™ of Sanofi Pasteur awarded tender
- Country of Origin: France
- Quadrivalent, inactivated
- Vaccine Composition
 - A/Michigan/45/2015 (H1N1)pdm09-like virus
 - A/Singapore/INFIMH-16-0019/2016(H3N2)-like virus
 - B/Colorado/06/2017-like virus
 - B/Phuket/3073/2013-like virus

VaxigripTetra™ (Sanofi)

- For persons **aged 6 months or above**
- Dosage for **aged 6 months or above**: 0.5ml
- 0.5ml pre-filled syringe with needle
- **Intramuscular / Subcutaneous**
- Expiry date: end of month marked on package

Overview of RVP

- Residential Care Homes (RCHs) / Designated Institutions (DIs) invite private doctors enrolled to RVP – Visiting Medical Officers (VMOs) to provide on-site vaccination
 - a form of public private partnership
 - 475 VMOs enrolled under RVP 2017/18 (list published in CHP website)
 - a familiar and convenient place for residents, PID and staff
- Injection fee of HK\$70 per dose will be reimbursed to VMOs through the eHealth System (Subsidies) (eHS(S)) after the injections in 2018/19 season

Vaccination Period

- Seasonal influenza vaccination
 - Start on 24 Oct 2018

- Pneumococcal vaccination
 - 23-valent pneumococcal polysaccharide vaccine (23vPPV)
 - ◆ Ongoing since commencement in October 2009
 - 13-valent pneumococcal conjugate vaccine (PCV13)
 - ◆ Ongoing since commencement in October 2017

Pneumococcal Vaccine

Prevenar 13 (Pfizer)

13-valent pneumococcal conjugate vaccine (PCV13)

- 0.5ml pre-filled syringe without needle (needles separately provided)
- Intramuscular
- Expiry date: end of month marked on package

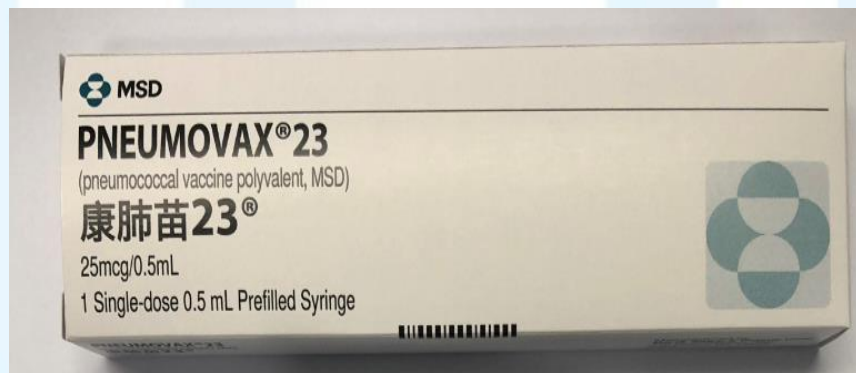


Pneumococcal Vaccine

Pneumo-23 (MSD)

23-valent pneumococcal polysaccharide vaccine (23vPPV)

- 0.5ml pre-filled syringe without needle (Needles separately provided)
- Intramuscular
- Expiry date: end of month marked on package



Logistics

Before Vaccination

- **DH:**
 - supplies and delivers consent forms, vaccines, sharp boxes and immunization cards to RCHs / DIs before the scheduled vaccination
- **RCHs / DIs:**
 - send consent forms signed by eligible residents / PIDs and staff to VMO 10 days in advance for checking
- **VMO:**
 - should perform prior checking of vaccination history and eligibility for all recipients through eHS(S) (vaccination should be delayed if checking has not been done)

Before Vaccination

- After checking in eHS(S):

- VMO should fill in the vaccination date of previous dose on the consent form

Before Vaccination

- Create accounts for new eligible clients if necessary
- Confirm with RCH / DI date and time for vaccination and that adequate number of vaccines are ordered and **properly stored** in RCH / DI (with cold chain and temperature monitoring)

Vaccination in RCHs / DIs

- Ensure the recipients' vaccination record have been checked through eHS(S), vaccination card or history from recipients or relatives
- Pay particular attention to those who are newly-admitted to the RCH
- VMO **should be present** and oversee the whole vaccination process, ensure personnel involved in vaccination are qualified/trained to perform vaccination duties

Vaccination in RCHs / DIs

- Ensure the personnel involved in vaccination are qualified and trained in emergency management of severe immediate reactions and are equipped to do so and to supervise and stand-by for emergency
- Read carefully the vaccine information, noting especially the **contra-indications, route of administration, dosage and expiry date, storage and handling**
- Check the **consent form, identity of the recipients and the medical conditions** of the recipients before vaccination
- **Counterchecking identity** of residents against consent form and identity document before vaccination

Vaccination in RCHs / DIs

- Ensure **correct vaccines** (SIV or pneumococcal) to be given to recipients and the vaccines are **unexpired** and in good condition
- Injection of one kind of vaccine to all recipients before giving the other kind of vaccine
- Separate injection date for SIV and pneumococcal vaccine (in different injection sites, common practice: left SIV vaccine; right pneumococcal vaccine (左流右肺))

After Vaccination

- Proper documentation:
 - vaccination card, consent form, and the consent list (e.g. signature and date)
- Make claims in eHS(S) **within 7 days** of injection (to keep records in eHS(S) updated)
- Report vaccination incidents to Vaccination Office of DH as soon as possible
- Report Adverse Events Following Immunisation (AEFI) if any
- Keep true copies of consent forms for 7 years

Points to Note

- Only use vaccines supplied by DH
- Provide vaccination service on-site in RCHs / DIs
 - Do not charge additional fee from residents / PIDs or staff
- Do not share the injection fee with RCHs / DIs
- Make claims under RVP instead of Vaccination Subsidy Scheme (VSS)
- Pre- and post-payment checking

Vaccination to mentally-incapacitated residents without guardians

- If the in-charge of RCHs / DIs confirmed that the guardian / parent of the resident cannot be contacted, either Part III or Part IV should be filled
- Part III: to be completed by Relative of the recipient
- Part IV: to be completed by In-charge Person of RCH
- ***For the benefit of the residents, VMO can provide vaccination to them after assessment and considers the vaccination is in the best interest of the them***

Arrangement of SIV mop up vaccination for staff and residents of RCHs

- Arrange mop up vaccination
- If VMO is not available, RCHs could contact VO for staff / residents' referrals to GOPCs for mop up vaccination starting from 1.1.2019

Inspection to RCHs

- To evaluate and improve vaccination procedure and logistics
- DH staff may randomly conduct onsite inspection of the services provided

Information prepared for VMOs

- Terms and Conditions of Agreement
- Doctors' Guide (on-line version on CHP website)
- FAQs
- 5 steps of checking vaccination records in eHS(S)

Five steps of checking vaccination record in eHealth System
(Log in eHealth System using English version)

Step 1: Validating medical officer (VMO) either duly completed consent form from Residential Care Home (RCH) at least 10 days before vaccination day.

Step 2: Check recipient's eligibility for:

Seasonal influenza vaccination (SIV):

- All residents and staff are eligible.

Pneumococcal vaccination (23vPPV):

- RCHs for Elderly: all residents who have never received 23vPPV before are eligible.
- RCHs for Persons with Disabilities: residents aged 65 or above who have never received 23vPPV before are eligible.

Please check whether RCH code & personal data are filled in.

Check the completeness of the Consent Form.

Fill in the date of vaccination after providing the vaccination.

Step 3: Log in the eHealth System and select the "Vaccination Record Enquiry" function.

Step 4:

If recipient has a validated eHealth account

Final Step 5:

If the recipient has a validated eHealth account and the matched vaccination records are found, the records are shown.

You may press "Return" to start over checking for another recipient.

If recipient does not have a validated eHealth account

If the recipient does not have a validated eHealth account, you have to input name and gender for searching vaccination records.

Check recipient's SIV record

- **Seasonal influenza vaccination:** Residents and staff of RCHs should get vaccinated every year.
- If recipient has already received SIV on or after 1 Sep 2014, no further dose of SIV should be given under RVP 2014/15.

Check recipient's 23vPPV record

- **Pneumococcal vaccination:** For residents who have received 23vPPV at the age of 65 years or above, no further dose of 23vPPV is required.

Residential Care Home Vaccination Programme 2017/18 has commenced on 25 October 2017. All residents and staff of Residential Care Homes for Elderly (RCHE) and Residential Care Homes for Persons with Disabilities (RCHD), non-institutionalised Persons with Intellectual Disability (PID), receiving services in designated institutions serving PID (such as day activity centres, sheltered workshops and special schools for PID) are eligible to receive free Seasonal Influenza Vaccination provided by Visiting Medical Officers (VMOs) enrolled to the programme. Residents of RCHE and residents of RCHD who aged 65 years or above are eligible for one dose of free 13-valent pneumococcal conjugate vaccine (PCV13) and one dose of free 23-valent pneumococcal polysaccharide vaccine (23vPPV).
