## For doctors who have not yet joined the VSS

For doctors who have not yet joined the VSS, for your information, the VSS, administered by the Department of Health (DH), is a scheme that subsidises target groups of Hong Kong residents to receive vaccinations from private medical doctors enrolled in the VSS. The enrolment guide and the enrolment application form for private doctors to enrol as healthcare providers are available at the Centre for Health Protection (CHP) website (https://www.chp.gov.hk/en/features/45858.html). You may wish to note that all doctors under the VSS, including new enrolees and doctors already enrolled, are required to be on the **Primary Care Directory (PCD)**. The details and
