Press Releases

Clinical Incidents related to COVID-19 vaccination at RVP

- "Preliminary investigations revealed that, on December 18, healthcare workers from the medical organisation concerned visited an RCHE ...and administered the Comirnaty XBB COVID-19 vaccines, which were 12 days beyond the recommended use-by date, to two residents. According to the vaccine manufacturer's recommendation, the Comirnaty XBB COVID-19 vaccine should be stored at 2 to 8 degrees Celsius after thawing and should be used within 70 days,"
- 2. "Upon reviewing the vaccine orders and vaccination records, the DH found that the doctor concerned visited ..., an RCHE in..., ...to provide vaccination services. During these visits, he administered Spikevax JN.1 COVID-19 vaccines that were beyond the recommended use-by date to 18 residents. According to the manufacturer's recommendation, the vaccine should be stored at 2 to 8 degrees Celsius after thawing and should be used within 30 days.
- 3. "Upon reviewing the vaccine orders and vaccination records, the DH found that the doctor concerned administered Spikevax JN.1 COVID-19 vaccines that were beyond the recommended use-by date to seven residents at ..., an RCHD in ..., on May 22. While the COVID-19 vaccines concerned have not exceeded their expiry dates, they should be stored at 2 to 8 degrees Celsius after thawing and used within 30 days, according to the manufacturer's recommendation."

Availability of JN.1 mRNA vaccines for adult

- Current Spikevax JN.1 vaccines with batch number 3048234 will expire on 5 Nov 2025, when stored frozen at -50°C to -15°C. This batch of vaccines will continue to be distributed until late Oct 2025.
- After that, Comirnaty JN.1 vaccines in multidose vial will be distributed for use.
- Comirnaty JN.1 vaccine in multidose vials will replace the current Spikevax JN.1 for ordering via the COVID-19 Vaccines Ordering System starting from 21 Oct 2025 11:00 am.

Major updates:


- Repositioning of "Use by Date" to the top row
- Clearer date format in DD MMM YYYY for improved clarity
- Omission of time to minimize distractions
- Bilingual text for "Use by Date" & "Thawed Date"
- Removal of 2D barcode
- Increased label and font size for better readability

Reminder:

- For daily operation, please refer to "Use by Date" on the outer box on a regular basis and prior to vaccine administration, as the information is not shown on the label of individual vials
- Vaccine can be used until the end of the labelled "Use by Date".
- For example, if the "Use by Date" on the label is "14 OCT 2025", it means the vaccine can be used **until 11:59 pm** on that date.
- Vaccines that are beyond the "Use by Date" should not be used.

Important Points to Note

- Comirnaty JN.1 vaccines will be thawed prior to delivery. Thawed vaccines can be stored at 2°C to 8°C for up to 10 weeks. For daily operation, please refer to "Use by Date" on the outer box on a regular basis and prior to vaccine administration, as the information is not shown on the label of individual vials. Vaccines that are beyond the "Use by Date" should not be used.
- According to the package insert, the unopened vials can be stored for up to 12 hours at temperature between 8°C and 30°C.
- Multidose vials contain <u>6 doses of 0.3mL each</u>. No dilution is required.
- Discard any unused vaccine <u>12 hours</u> after first puncture.
- Please note that ALL Spikevax vaccines with batch number 3048234 will expire on 5 Nov 2025. Any remaining vaccines should be removed from the medical fridge, quarantined in a lockable cabinet and marked "Do Not Use" on the outer packaging according to established procedure. Please report the remaining quantity of expired vaccines to RVP team, and DH will collect these vaccines asap.



Recommendation on COVID-19 vaccination:

- priority groups and vaccination schedule remain unchanged at the moment
- recommendation / arrangement for 2025/26 has just been published on 23 October 2025 and details of implementation will be further announced.

Vaccine Ordering


- Same as current practice for vaccine ordering via COVID-19 Vaccines Ordering System: https://covid_vac.chp.gov.hk/
- Order made after 21 Oct 2025 11:00am will be supplied with Comirnaty JN.1 vaccine
- Different from Spikevax JN.1 used before, LDV syringes (instead of needles) are required for administration of Comirnaty JN.1
- LDV syringe order quantity will be automatically calculated by the system based on order history, please retain the remaining syringes for future use.
- Please place vaccine orders at least 10 calendar days before the vaccination date.
- Vaccine will be delivered within 1 week prior to the vaccination date as far as possible
- LDV syringes will be delivered separately

Comirnaty JN.1 multidose vial (2.25 mL)

One multidose vial (2.25 mL) contains 6 doses of
 0.3 mL

Gently mix by inverting vials 10 times prior to use.
 Do not shake.

- Appearance after mixing: white to off-white dispersion with no particulates visible
- Withdraw 0.3mL of Comirnaty JN.1 using low dead-volume (LDV) syringe
- Record appropriate date/time on the vial
- Discard 12 hours after first puncture



Vaccine Management – Cold Chain

- Data logger
 - Check current, max. and min. temperature of the refrigerator by generating a temperature log from data logger daily
- Maximum-minimum thermometer
 - record current, max. and min. temperature in the "Daily Fridge Temperature Chart" manually 3 times daily each working day, preferably in the morning, at noon and in the afternoon
 - Reset after each recording
- Min. Temperature ≤ Current Temperature ≤ Max. Temperature
- Contingency plan should be in place for vaccine storage in the event of PBVR/ medical fridge storing vaccines malfunction or electricity disruptions
- Please quarantine the affected vaccines and report to PMVD immediately in case of temperature excursion (outside the recommended range of +2°C to +8°C)

Vaccine Management – Labelling

- Vaccine tray in PBVR/ Medical Fridge storing vaccine
 - Vaccine name
 - Strength (only 1 strength for RVP)
 - Use-by date
 - Lot number



- Vaccine vials and syringe [For multi-dose vials]
 - Vaccine name
 - **Use before date** & time
 - Lot number

Wastage reduction

- Please ensure your venue have preventive measures in place to avoid unnecessary vaccine wastage
 - Eg. only sufficient but not excess stocks of vaccine should be stored at your venue.
- Please only take out the required quantity of vaccines from refrigerator for preparation when required.
- The unused vial / pre-filled syringe should continue to be kept in the outer box and stored in a refrigerator (2°C to 8°C).
- PMVD will review wastage rate on various venues from time to time.

Report & collection of remaining COVID-19 vaccines

Please remind the RCH under your purview to report the remaining quantity of expired vaccines to RVP team, and DH will collect these
