**Maintain Listing in Primary Care Directory (PCD) for
2022/23 Vaccination Subsidy Scheme (VSS)**

Further to our email of 8 June 2022 providing a few updates on VSS scheme, we would like to remind you to maintain your PCD listing for the coming 2022/23 VSS season.

For your information, the arrangement of waiving PCD requirement for a period of 6 months from 11 Feb 2022 will end on 10 Aug 2022. Doctors who have already enrolled in VSS must maintain listing in the PCD. If you wish to continue enrolment in VSS in the coming 2022/23 season, please ensure that you are listed in PCD when the new season commences. Doctors who could not meet this requirement may be temporarily suspended from providing service under 2022/23 VSS until he/she has fulfilled the PCD's requirement and listed in PCD again.

To maintain listing in PCD, doctors are required to comply with relevant Continuing Medical Education (CME) requirement. The Primary Healthcare Office of Food and Health Bureau will conduct regular checking on doctors' CME attainment in January and July of each calendar year. You may refer to the Annex regarding the CME attainment to be considered in the coming checking exercise.
